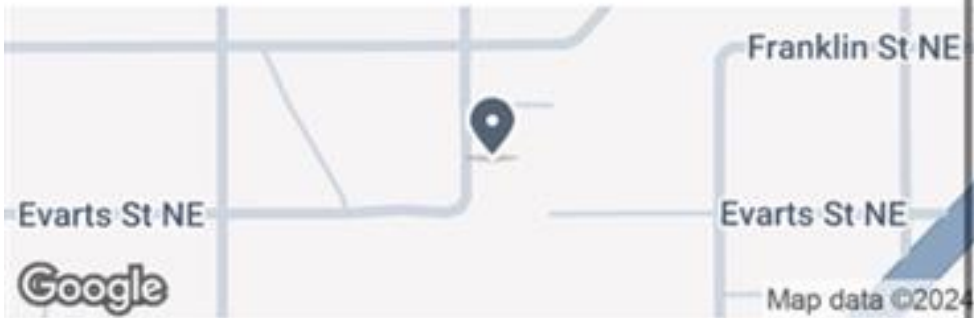

Electronic check conversion

Company fees & surcharges
