The Federal Universal Service Charge (FUSC) is a Verizon wireless charge that is subject to change each calendar quarter based on contribution rates prescribed by the FCC. On April 1, 2025, the FUSC decreased to 11.19% of assessable wireless charges, other than separately billed interstate and international telecom charges.
