### Important Information about MileagePlus Earning

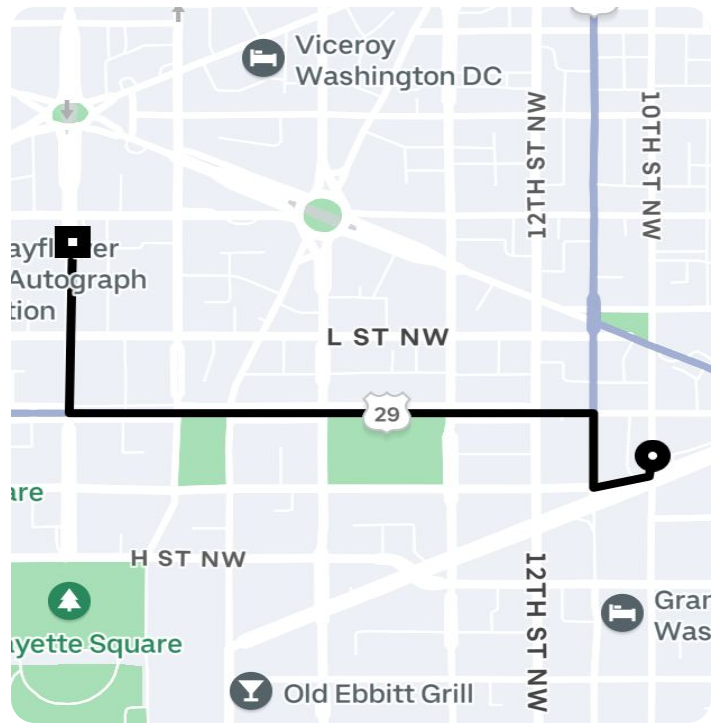

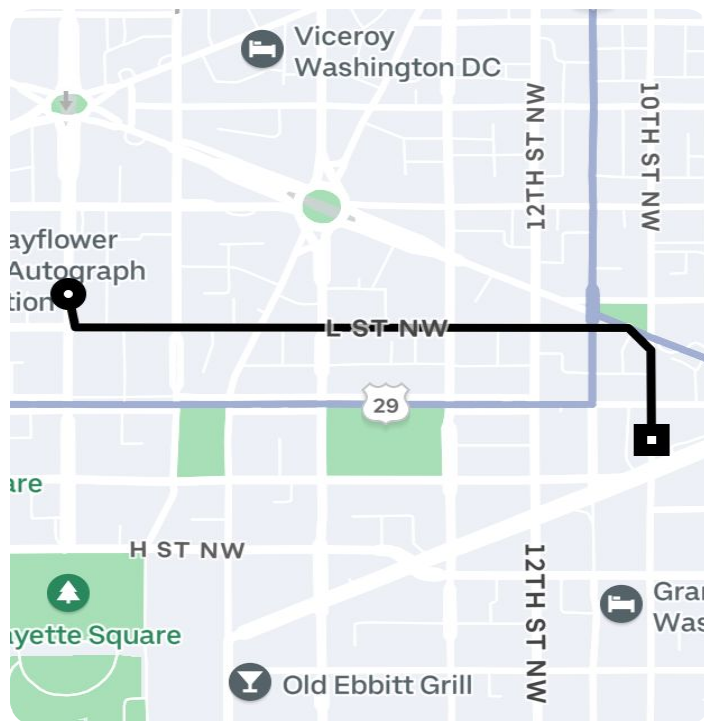

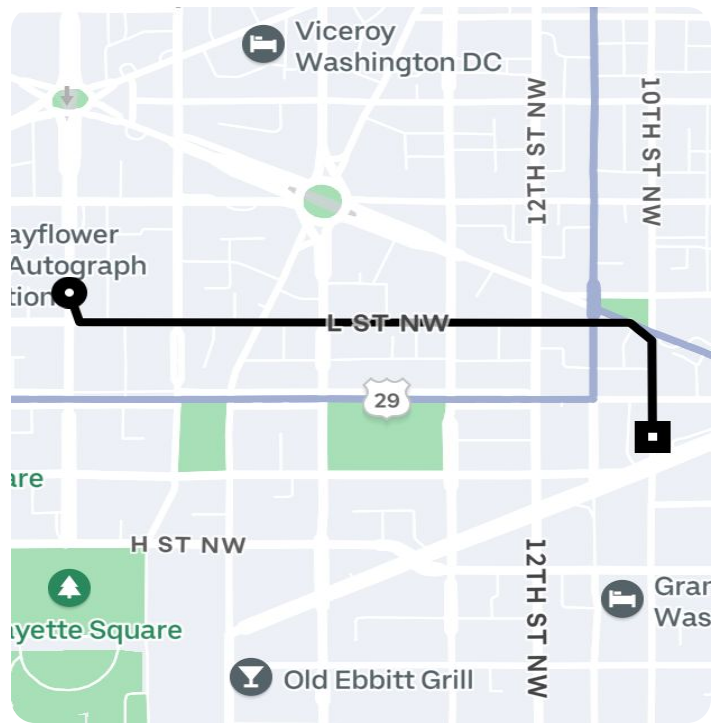
