By submitting a check for payment, you authorize us to initiate an electronic debit from your bank or asset account. If we cannot collect the funds electronically we may issue a draft against the bank or asset account for the amount of the check. This conversion rate may differ from rates in effect on the date of your Charge. Charges converted by establishments (such as airlines) will be billed at the rates such establishments use.
